- Types of membership:
Life: Membership for the remaining lifetime of the club. **Ordinary:** Rottweiler owners over 18 years of age.
Family: Comprising parents and children not over the age of 18 years. The parents shall each be Rottweiler owners. **Junior:** Persons not included in a Family Membership who are under the age of 18 years. **Non-Rottweiler Owners:** Persons over 18 years of age who are not Rottweiler owners.
- Subscriptions shall be for one (1) year from the first day of January until the last day of December, provided that in the case of new members joining in the second half of the Club's financial year, the subscription shall be halved for that year only and shall be due on that date.
- Membership will lapse:
 - upon failure to pay entry fee and initial subscription within 30 days of the date of submission of application;
 - upon failure to pay a renewal subscription by the 31st January of the current financial year.
- The Natal Rottweiler Association's committee strongly recommends that all members ensure that they have insurance which covers any and all dog-related incidents.
- Confirmation of membership will be sent to applicants once the application has been approved by the Committee of the Natal Rottweiler Association.

CONDITIONS OF MEMBERSHIP:

- I hereby declare to abide by the rules and regulations as laid down in the constitution of the Natal Rottweiler Association as well as any rules and regulations pertaining to training and other Club activities as decided upon by the Committee of the Natal Rottweiler Association. (A copy of the constitution is available on the club's website, or from the Secretary)
- I am personally responsible for the control of my dog(s) at all times and shall personally be liable for any claims that may arise due to any injuries or damage caused by my dog(s).
- I indemnify the Natal Rottweiler Association, under whose auspices the events/training classes are conducted, against any claims which may be made against it in respect of any action by my dog(s) and/or by my failure to control my dog(s).
- In the case of minors, the parent or legal guardian must assume these responsibilities.
- I am personally responsible for cleaning up after my dog(s).
- I will ensure that my dog's vaccinations are up-to-date at all times, including rabies. Please attach a copy of your dog(s)'s vaccination book when handing in this membership form and ensure that an updated copy is handed in after each vaccination. Dogs without up-to-date vaccinations will not be allowed on the training field.
- Vehicles may not be driven on the training area. Drivers may only drive along the perimeter of the field, as indicated on the diagram below. Vehicles may park on the perimeter of the field.
